

**Notice of Proposals of making of Various Road Traffic Regulation Orders
Affecting the District of Winchester City Council**

Winchester City Council as agents for Hampshire County Council proposes making the undermentioned road traffic regulation orders:-

The Hampshire (Various Roads, Denmead) (Parking Places and Restriction of Waiting) Order 2008 (Variation No.3) Order 2010.

HAMBLEDON ROAD (B2150)	NORTH-EAST	FROM A POINT 17.2 METRES NORTH-WEST OF ITS JUNCTION WITH MARTIN AVENUE TO A POINT 13.7 METRES SOUTH-EAST OF THAT JUNCTION.
HAMBLEDON ROAD (B2150)	SOUTH-WEST	FROM A POINT 17.5 METRES NORTH-WEST OF ITS JUNCTION WITH THE HEATH TO A POINT 99.3 METRES NORTH-WEST OF ITS JUNCTION WITH BERE ROAD.
HAMBLEDON ROAD (B2150)	NORTH-WEST	FROM A POINT 24.0 METRES NORTH-WEST OF ITS JUNCTION WITH BERE ROAD TO A POINT 15.3 METRES SOUTH-EAST OF THAT JUNCTION.
